To be bound by and to comply with all of the other provisions of the cooperative's certificate of incorporation, bylaws, rules, regulations, policies, and rate schedules established pursuant thereto, as all the same now exist or may hereafter be adopted or amended, and with the provisions of any supplemental contract that may be executed by me with the cooperative.

I hereby certify that I owe no existing bills to Rutherford EMC, and if for any reason my belief in this regard is in error, I hereby authorize Rutherford EMC, in consideration of its presently furnishing electricity to me, to add such outstanding bills to my present account for usual collection policies to apply.

It is also understood and agreed that, after any termination of membership, I may, by paying a new membership fee and any deposit required, and any accounts still owed to the cooperative, renew and reactivate this application to the same effect as if it had been newly and identically executed on the date of such payment or payments.

As a non-profit electric cooperative, Rutherford EMC returns amounts in excess of operating costs and expenses to the members in the form of patronage capital credits. If you should move away from the Rutherford EMC service area, always make sure we are advised of any change of address. When patronage capital credit refunds are issued, they are mailed to the most recent address we have on file. In addition, when security deposits are refunded, they are also mailed to the most recent address we have on file. Rutherford EMC makes every effort to contact you if your check should be returned to us as undeliverable. Unclaimed patronage capital credits are forwarded to the State of North Carolina after three years. Unclaimed security deposits are forwarded to the State of North Carolina after approximately two years. An alternative to forwarding unclaimed monies, either patronage capital credits or security deposits, to the State of North Carolina is for you to sign a voluntary revocable assignment of these monies to Rutherford EMC. This assignment is not a requirement for you to receive or continue to receive service. If you make this assignment, you have the right to revoke it at any time before your death. Please be advised that any unclaimed funds that have been donated to the capital fund of Rutherford EMC prior to your revocation, if any, shall remain the property of Rutherford EMC.
