**SCHEDULE OL  
OUTDOOR LIGHTING**

**AVAILABILITY**

Service is available under this Schedule to any Consumer in the territory served by the Cooperative for lighting of outdoor areas from dusk to dawn each day. Lighting will be provided by fixtures mounted with brackets on the Cooperative's poles. Lighting of streets in residential subdivisions is available under this Schedule; however, no lighting will be prorated among consumers in the area. Service under this Schedule is subject to established service rules and regulations of the Cooperative.

**CONDITIONS OF SERVICE**

The Cooperative will furnish and maintain all facilities required to provide service. If repairs are needed, service will be restored by the Cooperative within a reasonable period of time following notification from the Consumer. High Pressure Sodium or LED luminaries will be provided by the Cooperative, unless the Cooperative chooses otherwise or upon special request by the Consumer prior to installation. Rental is based upon continuous service and is not available for seasonal or other part-time operation.

[1] Floodlighting service generally is not available in residential areas and may be withheld or discontinued at the option of the Cooperative.

[2] All decorative lighting is subject to a ten year minimum contract period.

### POLES

Fixtures will be mounted on existing distribution system poles without additional charge. When the Consumer requests a separate pole, or poles, to be installed for security lighting, the monthly charge will be increased as provided below with the following exceptions:

1. For installations prior to May 1, 1992, no charge will be made for the first 30 foot pole and \$1.25 per month will be charged for each additional 30 foot pole, and
2. For installations between May 1, 1992 and June 30, 1999, the monthly charge for each 30 foot pole will be \$3.50.

Standard wood poles may be installed upon request for an extra monthly charge per pole of:

### OTHER FACILITIES

Luminaries and other non-standard lighting facilities can be installed on request, at the Cooperative's option, at the rate above for comparable service plus an extra monthly charge of 1.5% of the difference between the estimated installed cost of requested facilities and the estimated installed cost of standard facilities.

### UNDERGROUND CONDUCTORS

Underground conductors can be installed to luminaries under the provisions of the Cooperative's Underground Installation Plan. The additional monthly charge for the underground conductor system will be \$4.00 per month for service not exceeding 150 feet plus \$.03 per foot for all over 150 feet.

Note: There will be no additional charge for the installation of underground conductors to luminaries when the conductors can be installed concurrently with the Cooperative's underground primary and secondary conductor distribution system.

### OTHER PROVISIONS AND DEFINITIONS

1. Mounting brackets longer than 23 inches but not exceeding 20 feet are available for an additional monthly charge of \$4.00 per bracket.
2. Service using overhead conductors is not available in any area designated by the Cooperative as an underground distribution area, nor in any area, location, or premises being served from an underground source.
3. "Suburban" luminaries are those having standard "NEMA-style" heads with vertical-burning lamps.

### WHOLESALE POWER AND TIER ADJUSTMENT

Any power cost adjustment needed to recover wholesale power costs fully and any TIER adjustment needed to maintain the Cooperative's financial condition shall be reflected as an increase or decrease on a kWh basis on all power sold under this Schedule.

**PAYMENT**

Each bill under this Schedule is due and payable on the date of the bill at the office of the Cooperative and is past due and delinquent on the fifteenth day after the date of the bill.

**SALES TAX**

Any applicable state and local sales taxes will be added to charges under this Schedule.
